

Terms & Conditions: Cecii License

The purchase of the study called “Cecii – Define the Optimal Project Management Framework for your Organisation” (hereafter called “Study”) includes a License Agreement between Wako Tako CommV, a company established and registered in Belgium under registration number 0749.869.881 (hereafter called “Wako Tako”) and the organisation purchasing the study and license (hereafter called “Client”). The following provisions are in effect:

1. Intellectual Property

Cecii is a registered trademark of Wako Tako. The Cecii Method, as explained in the study “Cecii – Define the Optimal Project Management Framework for your Organisation” falls under the intellectual property of Wako Tako.

2. Rights of the Client

Through the purchase of the Study the Client obtains a License to use the Study and the Cecii Method within its organisation. The limits within which the Client can use the License are defined by 1. The organisation name of the Client, 2. The country within which the Client wishes to use the License and 3. The VAT number of the Client (in case the Client does not have a VAT number, its registration number will apply). All three conditions must be met to determine the License boundaries. Within this organisation the following rights are granted to the Client:

- The free distribution of the Study to all departments and/or personnel that can benefit from the usage of the Cecii Method
- The free usage and application of the Cecii Method, as described in the purchased Study, for the organisation and the projects of the Client
- The start date of the License for the Client shall take effect five working days after the payment of the invoice related to its purchase has been received by Wako Tako. It shall remain in effect for as long as the Client adheres to the conditions set forth in this License Agreement

3. Limitations of the License

The following limitations apply to the usage of the License by the Client:

- This License does not constitute any transfer of intellectual property rights. Wako Tako remains the sole proprietor of the Cecii Method and trademark
- The Client may not distribute the Study outside the boundaries of its organisation as defined in Article 2
- The Client may not develop or provide any commercial services to any third parties based on the Study or the Cecii Method without the explicit written permission of Wako Tako
- The Client may not use the Study or any part of its contents to develop or train any Artificial Intelligence platform or system or similar technology without the explicit written permission of Wako Tako

In case the Client breaches any of the conditions set forth in this License Agreement, Wako Tako has the right to unilaterally revoke the License granted to the Client and to obtain compensation from the Client for any damages suffered by Wako Tako from this breach.

4. Miscellaneous

This Agreement shall bind the Parties and their legal successors. This Agreement shall be governed by Belgian law. Any dispute relating to this Agreement shall be submitted to the courts of Antwerp. Failure to enforce any provision shall not constitute a waiver of enforcement of any other provision. This Agreement may not be amended except in writing signed by both Parties. If any provision of this Agreement is found to be invalid, unenforceable, or null, it shall be replaced by Wako Tako by a valid provision that best reflects the intent of this Agreement.
